SETTLING INTO THE NEW TOWNSHIP BUILDING

Welcome!

The new municipal complex opened its doors to the public on Monday, June 24, 2019. After planning, building and moving, the Board of Supervisors, Township staff and residents attended the very first meeting, held on July 16, 2019 in the new Doylestown Township Municipal Building!

Entering through the double doors and continuing straight into the bright lobby highlights the open space concept of the new Doylestown Township Municipal Building. The lobby features the well-known mural by Helen McCook and serves as an artistic and historical backdrop to the waiting area.

Across from the waiting area are glass sliding panels for easy communication to the code enforcement office and the reception desk. Behind both windows are smiling faces of Township employees waiting to answer any questions you may have! The lobby area has an environmentally friendly water bottle fill station and four ADA compliant restrooms.

Continuing straight through the lobby you will see two TVs hanging on either side of the entrance of the Community Meeting Room. One monitor displays an eye catching slideshow featuring important dates, monthly meeting schedules and upcoming events. The other TV plays programming which mirrors the DTV channel.

Before entering the Meeting Room there is a small conference room that is open to the public and to the right, is the telecommunications room which houses the advanced video and audio equipment used to record the Board of Supervisors meetings.

Entering the Community Meeting Room your eye is drawn to the natural stone fireplace and the warm red barn wall color that captures the rural influence of Bucks County. The Doylestown Township seal placed in the center of the stone wall brings all the colors together. The meeting room has grand high ceilings, exposed wood beams and skylights for natural light.

We welcome you to come see the Community Meeting Room and the new Doylestown Township Municipal Building with your own eyes!



A LOOK BACK AT *Summer 2019!*



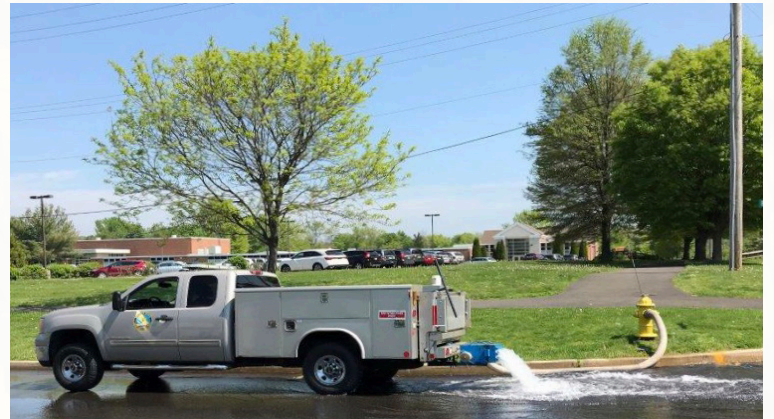

WEBSITE RE-VAMP PROJECT UNDERWAY

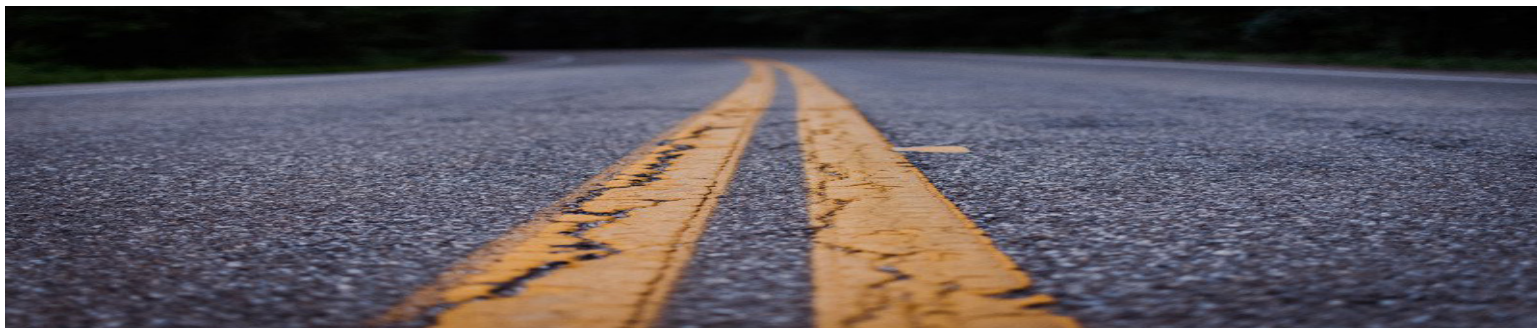


Citizen communication, branding and marketing have been on the Township's radar recently! A communication survey printed in last year's fall newsletter initiated conversation on how to best market the Township and paved the way for a website re-vamp project.

With help from the Board of Supervisors and various Township residents, we were able to determine what steps to take to better communicate with the public. Directing the community to our website was a major takeaway.

The current website is outdated, hard to navigate and lacks a wow factor but the need for an updated Township website goes deeper than the outside appearance. The inner workings of the website are confusing even for a tech savvy person. The re-vamp will not only update the website's appearance and usability but will generate a new tool for the Township to reach residents and the community.

ASSET MANAGEMENT ROAD PROGRAM

Dave Tomko, Director of Operations, introduced the CS Datum asset management / geographic information system (GIS) program that the Township has implemented to catalog the township assets (signs, drainage systems, water system) and analyze roadway paving and maintenance costs. This program will help the public works departments and overall operations of the township modernize and streamline information storage. The long term goal of the program is to catalog township assets, as well as consolidate mapping, including street maps, Bike and Hike maps, water system map, as well as manage the MS4 stormwater requirements! Another major component of the asset management program is RoadBotics, a tool that surveys the roads to identify damage and rate surface conditions.

The combination of the CS Datum asset management/GIS and the RoadBotics programs will improve the Township's ability for departmental integration while providing a solution to information storage. The Township will be able to assess and develop future Township Road Programs with the addition of these two software packages. Over the past year the Township has had interns, the Public Work staff and even police officers contributing to inputting data such as street signs, traffic lights, fire hydrants, inlets and more!

The goal is to have all the assets within the Township systematically accounted for to build an accurate asset management database. The future is bright as the Township continues to use the GIS based programs to build a database and streamline information for future use.

TOWNSHIP ACHIEVES SUCCESSFUL AUDIT

Every year the Township hires an outside accounting firm to audit Township books and prepare Township financial statements, and this year it was Major and Mastro, LLC who completed the audit. Our financial statements are filed with the Commonwealth of Pennsylvania and the audit is posted on our website. In addition, the statements are shared with financial institutions that oversee our debt, and monitor the Township's bank accounts and investments. Moody's Investors Service rated the Township Aa1. This makes the Township appealing to investors when we issue bonds. We had a successful audit with no management letter and received a "clean" opinion, the highest audit report under General Accepted Accounting Principles. This is the 9th year in a row the Township has had a successful audit. We appreciate the finance department team and township employees for their dedication and hard work.

DTMA CORNER

The Doylestown Township Municipal Authority is your community based and locally controlled public water provider.

The DTMA is governed by a five member Board of Directors who all reside in Doylestown Township.

All the members have the best interests of the DTMA customers and Doylestown Township in mind at all times. This past year has been very busy for the Doylestown Township Municipal Authority. The Authority partnered with the Department of Environmental Protection and Buckingham Township to complete the \$1.2 million Furlong Water System Project.

This significant project established a public water system in Furlong to alleviate long standing private well with Trichloroethylene (TCE) chemical contamination in Doylestown Township residences and businesses.



In addition, our system is growing and soon we will be supplying water to the new "University Village" corridor in neighboring New Britain Borough. We look forward to partnering with New Britain Borough to provide a clean and safe drinking water supply.

Looking ahead in the upcoming year, DTMA staff continues to maintain and upgrade our distribution system as needed to optimize system performance and ensure that the quality of the water we provide is safe, clean and affordable for the residents and businesses of the community.

LEAF AND YARD WASTE COLLECTION INFORMATION



The Township offers two ways to dispose of leaf and yard waste. One is the leaf drop-off located at Central Park and the other is fall leaf pick-up which is scheduled and conducted by your chosen trash hauler.

At the beginning of the year, the licensed trash haulers inform the Township the dates for leaf pick-up. Another way to dispose of leaves and brush is the fall leaf pick-up conducted by your trash hauler. The township makes this information available to residents by posting it on the Township's website and social media. The dates differ depending on your trash hauler.

See the dates below and call your trash hauler with any questions or concern regarding your fall leaf pick-up.

The leaf drop-off area is located at the New Britain Road entrance of Central Park and is open every third Saturday of the month from March to December, 9:00am to 11:00am. The Township collects leaves and yard waste such as small brush, sticks and limbs and puts them into a tub grinder which creates fresh composted mulch. The mulch that is created is re-used within the park system and is also available to residents to pick up during the site's hours of operation.

Yes, You. Without You, Kids Castle would just be a magical dream unrealized.

In 1997 volunteers, the Township and the community rallied together to build a magical place to play and through hard work, the gates of Kids Castle opened to the public. That hard work did not stop and continued throughout the years to preserve and refurbish our playground with tender loving care.

Fast forward 15 years later to 2012 when the best materials chosen at the time of construction were reaching the end of their lifespan. Again, volunteers rallied together and saved the Castle structure from demolition, but unfortunately all the surrounding play structures could not be saved and were removed.

In 2013 volunteers rose to the challenge again and began the Build the Kingdom project which focused on raising funds to replace all the play structures and updating the playground so it

can be enjoyed by children of all abilities including kids with special needs.

Six years later in 2019, volunteers have raised over \$500,000 to replace each play structure piece by piece. As the funds were raised, volunteers worked in partnership with the Township to rebuild the entire playground so the magic that is Kids Castle can continue on for future generations to enjoy.

It's been a long journey over the past six years to update and improve our beloved Kids Castle playground so children of all abilities can have a place to play. It has been an even longer journey since Kids Castle was first built in 1997.

All of this could not have been accomplished without You – the volunteers, the Township and the community. You opened your hearts and wallets each time the call went out to help.

Standing in front of our playground, visitors can certainly see a collection of wood, nails, and screws... What they don't see is the hundreds of loving hands that freely volunteered their time and efforts to stain that wood, hammer those nails, and turn those screws – and so very much more.

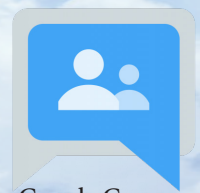

SEPTAGE MANAGEMENT REMINDERS

Cycle One residents must have their septic systems pumped and inspected and their well water tested for coliform bacteria by December 31, 2019. In doing so, you will be in compliance of the Septage Management Program and contributing to the overall health and safety of the community. Please remember that you must use an approved Township Pumper/Hauler because those companies have completed the proper paperwork to be included in the Septage Management Program here at Doylestown Township.

After your pumper/hauler has inspected and pumped your system, they should send the pumping report to the Township. If you receive a letter from the Township stating that we have not received your report, though you have had your system pumped, it may just be that the Township did not receive it and will communicate with you and your hauler to get the correct paperwork. As for your well water test, it is the homeowner's responsibility to send a copy of the completed water test to the Township. This can be mailed, faxed, emailed or even dropped off! We are located at 425 Wells Road, next to Central Park.

Remember to maintain a healthy septic system because water conservation is key!

Keeping You Up to Date

It's been an eventful summer. I look forward to getting back to Harrisburg this fall to fight for issues that matter the most to the 143rd.

Telephone Town Hall

I had my first telephone town hall on Wednesday, August 21st. It was an excellent way for us to gather – from the convenience of our homes – and talk about public priorities.

Respondents said that the biggest public issue facing the 143rd is 'roads and infrastructure' (57%), followed by 'access to health care' (21%), schools (15%) and jobs (6%).

Tohickon Creek Designation Update

Thanks to your public comments, PA Depts. of Environmental Protection and Conservation and Natural Resources are slated to perform more evaluations on Lake Nockamixon Dam to see what operational or physical changes there could affect aquatic life in the lower mainstem of Tohickon Creek.

I'll keep you posted on further developments.

Legislative Update

Recent Appointments

I'm proud to announce two statewide appointments that put me in excellent position to influence important local decisions affecting our communities.

Public Higher Education Funding Commission

I'll be working with the commission to review and recommend about higher education funding, affordability and effectiveness.

Governor Wolf's Suicide Prevention Task Force

I'll be working with legislators and citizens to develop PA's Suicide Prevention Plan — a long-term strategy to reduce suicide rates in PA and increase awareness for programs and services available to Pennsylvanians in crisis.

Protecting our Environment

When I return to Harrisburg in September, I'll be pushing for my bills to improve water quality and for other environmental improvements.

Safe Drinking Water Act

Perhaps literally nothing is more important to a public servant than ensuring that our drinking water is safe to drink. That's why I'm introducing a bill that would direct the Environmental Quality Board to establish state-level maximum levels for likely carcinogens in our drinking water. This bill also would direct the board to set limits in our water when two or more states have set maximum containment levels or limits on these pollutants. Pennsylvania's drinking water needs to be at least as safe as other states.

Implementing a Beverage Bottle and Can Deposit Program in PA (H.B.1322)

Beverage containers make up roughly 6% of the waste stream and 40-60% of all litter. My bill would create a 5-cent beverage bottle and can deposit program to encourage recycling in Pennsylvania.


