Bucks County Water & Sewer Authority has contracted Gilmore & Associates, Inc. to design a sanitary sewer system for the Pebble Ridge/Woodridge area of Doylestown Township which has been identified to have several failed/failing private on-lot systems. In order to complete the design process our survey crews will need to obtain the depth of the sewer outlet pipe for each dwelling unit. Therefore, our survey crews will need access to your house to locate and measure the depth of the sewer pipe in the basement/crawlspace, if available, and also take measurements from the cleanout(s) located outside your home.
