Minutes Approval

- Approval of Minutes from March 9, 2011 meeting (Mark)
 - Motion to approve: Dori, second: Dennis, passed

Old Business

- Turk Rd Survey (Mark)
 - We have responses: 44 out of 88.
 - Ed has volunteered to do tabulation and summary, like he did for Sauerman.
- TAC Brochure and Web Site update
 - Review of Warminster brochure. Special attention was drawn to the ranking system. Mark suggests we remove the ranking paragraph.
 - (from Lt. Logan, via email) Website has been updated and I attached a printout for your information of the TAC portion of Website. All items in blue have links to either additional information on email addresses. The "traffic@doylestownpa.org" will not be set up until the on-line form for reporting concerns is finalized and available through the website. (See attachment "Website")
 - Mark will put together a mockup for the committee's web page.
 - Dave M has not made any progress on the on-line form.
- Sauerman Rd update
 - (from Lt. Logan, via email) Sauerman Road speed limit signs had been ordered but have not yet been received by township road department. I have been assured that once they arrive they will be installed promptly.
- Castle Valley Update (Dave M)
 - There are people traversing the bridge in the wrong direction.
 - Complaints via Cynthia: driving time, sitting in traffic. Echoed by Ed.

New Development within the Township (Lt. Logan)

- None.

New Business

- Stop Sign and Speed limit issues on Park Drive/Campbell Road (See attachment 11-002911)
 - This is the neighborhood behind Genuardi's. Park/Campbell connects Old Dublin Pk and Swamp Rd. This is cut-through traffic.

- **Motion** by Dave, second by Dori, passed unanimously:
 - Add a recommendation 0: do a baseline speed study.
 - In #1, make the western intersection a yield sign, and the eastern one a stop sign.
 - Implement 2 and 3, posting 35 mph speed limit. We can't post 25 mph until we do a survey.

- Dave M asked if Willow Lane is posted 25 mph. He noticed non-standard signs that appear to be new on the road. This was requested by Willow Ln residents March, 2010.

- Jackie: Has Barbara Lyons mentioned to anyone about East Rd speed limit being reduced due to a culvert (in disrepair?) causing accidents. Report of a rolled vehicle. Mark: this has not been brought to the committee.

- Dennis: Sugar Bottom Rd complaint at a Supervisors meeting? Cynthia: take care of, they are satisfied.
