Analysis of development/local streets to be done, using streets classification. • Chief initiated a speed analysis of the streets in this area, so that we have a uniform picture of current status. About 30% of the streets have already been collected. • This will be a medium term project. We should wait until all of the stats have been collected from this area, and the updates on the road classification spreadsheet are completed, before making any decisions. • During February meeting discussed that a decision on how to progress should be made at the April meeting.
