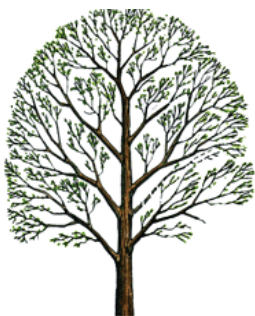

Arbor Day Foundation Tree Care Tips & Techniques

Trees increase the value of property, purify the air, improve water quality, prevent erosion, save energy, and add beauty to our surroundings. Spring is here and the trees are awakening from their winter hibernation.

Why not take a little time to ensure the health of the trees on your property?



Here are some things you should know about caring for your trees:

1. Do not over prune or top trees.

Never remove the main branches. If a main branch must be removed it should be cut back to where it is attached to another main branch or the trunk. Do not leave a stub. Removing the main branches reduces the amount of food that can be produced and makes the tree more susceptible to disease.

When pruning keep in mind that most species of trees should have a single trunk with many smaller side branches. Many people top trees because they block sunlight or grow into utility wires. When the top section is chopped off of a tree the small side branches continue to grow. The tree shape is often ruined and makes it look unsightly.



2. Trees thrive with mulch.

Mulch insulates the roots, prevents the growth of weeds, reduces lawn mower damage, and retains water. The mulch area can range between 3-10 feet in diameter, depending on the size of the tree. **Do not allow the mulch to touch the trunk of the tree.** Leave 2-4 inches between the mulch and the tree trunk.



3. Ring barking which is also called girdling can damage your tree.

Lawn mowers and weed whackers can strip a tree of vital membranes that allow food, water, and minerals to circulate throughout the tree. Mulching is a great way to create a safety zone around the tree.

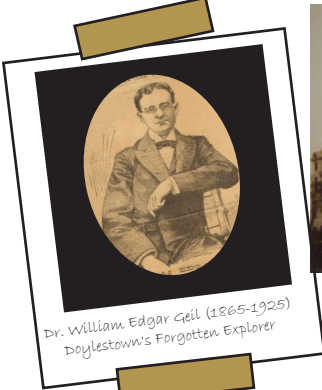

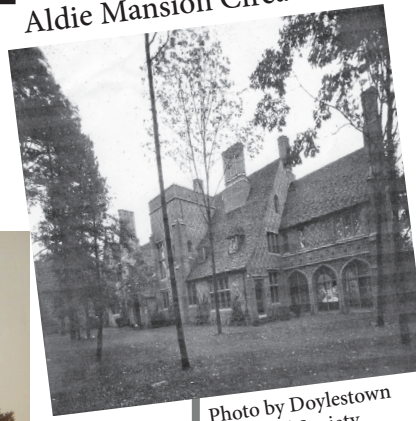

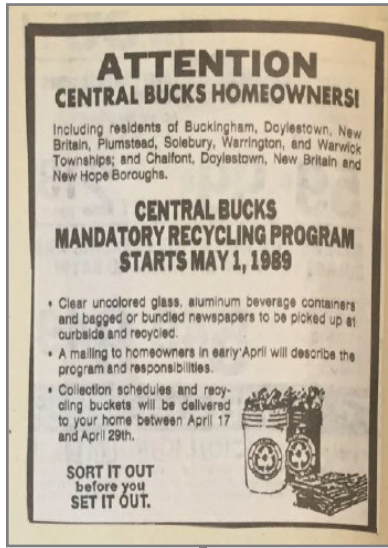
Proposed new township building 2018



ORDINANCE NO. 59

AN ORDINANCE ESTABLISHING THE OFFICE OF TOWNSHIP MANAGER IN THE TOWNSHIP OF DOYLESTOWN, BUCKS COUNTY, PENNSYLVANIA, PROVIDING THE MANNER OF FILLING SAID OFFICE, THE AMOUNT OF BOND, THE METHOD OF COMPENSATING SUCH OFFICER AND THE POWERS AND DUTIES OF THE OFFICE.

The Township of Doylestown, Bucks County, Pennsylvania, hereby ordains as follows:
SECTION 1. The office of Township Manager is hereby created by the Board of Supervisors of the Township of Doylestown Bucks County, Pennsylvania, subject to the right of the Board of Supervisors of the Township of Doylestown, by Ordinance, at any time to abolish such office.
SECTION 2. As soon as practicable, after the enactment of this Ordinance, the Board of Supervisors of the Township of Doylestown shall elect, by a majority vote of all of its members one person to fill the office of Township Manager, who shall serve until his successor is elected and qualifies. AN ORDINANCE TO ESTABLISH A PROGRAM FOR THE COLLECTION OF RECYCLABLE MATERIAL FROM RESIDENCES IN THE TOWNSHIP OF DOYLESTOWN FOR RECYCLING PURPOSES; TO PROHIBIT THE DISPOSAL OF RECYCLABLE MATERIALS INTO THE CONVENTIONAL MUNICIPAL SOLID WASTE DISPOSAL SYSTEM; TO EMPOWER THE MUNICIPALITY TO ADOPT AND PROMULGATE REASONABLE REGULATIONS THEREOF; AND TO FIX PENALTIES FOR THE VIOLATION THEREOF.
WHEREAS, conservation of recyclable materials has become an important public concern because of the growing problem of solid waste disposal and its impact on our environment; and
WHEREAS, the remaining permitted solid waste landfills are reaching their capacity;
WHEREAS, there is an increasing necessity to conserve our natural resources and
WHEREAS, the collection of recyclable materials from residences promotes the general interest;
NOW, THEREFORE, be it Ordained and Enacted and it is hereby Ordained in the Township of Doylestown, Bucks County of Bucks, State of Pennsylvania, as follows:
1. TITLE: The short title of this ordinance shall be the "Recycling Ordinance", and the same may be cited in the future as "Ordinance", and the same may be cited in the future as "Ordinance".

Household Hazardous Waste Collection Events

Household products containing toxic chemicals, like pesticides, oil-based paints, solvents, cleaning products, weed killers and automotive batteries can be a threat to people and the environment if improperly discarded. Never throw these materials into the trash, as the toxic chemicals may harm sanitation workers, or result in fires in collection vehicles. It is also not safe to pour them into a sink or storm drain as they can end up in the environment polluting the air, water and soil.

What can you bring?

Up to 25 gallons or 220 pounds of hazardous products. Keep in mind hazardous products will have cautionary works on the label, for example, *Danger, Warning, or Caution*. Other words or phrases that can signal hazardous products include: *poisonous, hazardous, combustible, flammable, corrosive, flammable, corrosive, volatile, caustic, irritant explosive, toxic, use with adequate ventilation, or avoid inhaling*.

Electronics are NOT accepted at these events.

This includes TVs, computers, cell phones and other corded devices.

Homeowners Guide To Stormwater Maintenance



What is Stormwater?

Stormwater is the water that runs off the land after precipitation, either in the form of rain or snowmelt. This infiltrates the soil and evaporates back into the atmosphere where it is used by plants. Water that runs off the land into streams or lakes is called storm water runoff.

Why should you care about Stormwater Management?

Stormwater runoff affects the environment as it can cause erosion of streams, sediment build up in lakes, and pollution of streams and lakes.

Anything that enters a storm sewer system enters the waterbodies we use for swimming, fishing and drinking.

The Effects of Pollution

- Sediment build up can destroy aquatic habitats.
- Excess nutrients can cause algae blooms and fish and other aquatic organisms can't exist in water with low oxygen levels.
- Bacteria and other pathogens can wash into swimming areas and create health hazards.
- Debris like plastic bags, six-pack rings, insecticides, pesticides, paint solvents, used motor oil and other fluids can poison aquatic life.
- Polluted stormwater affects drinking water sources. This affects human health and increases drinking water treatment costs.

BMPs: What are they, & what do they do?

BMP stands for Best Management Practice. This includes detention basins and non-engineered approaches like protecting open space to manage stormwater.

Stormwater Control Measures

- minimizing the amount of runoff
- slowing down the runoff
- infiltrating runoff
- evapotranspiring runoff
- filtering runoff

Our community has been designed with stormwater management in mind! Some BMPs are landscaped and others are buried so you might not see anything at the surface.

Pollution Solutions

Lawn Care

- Do not overwater your lawn. Use a soaker hose instead of a sprinkler.
- Use pesticides and fertilizers sparingly or not at all. Only use when necessary.
- Compost or mulch yard waste. Do not leave it in the street or sweep it into storm drains.
- Cover piles of dirt or mulch being used in landscaping projects.

Auto Care

- Use a commercial car wash that treats or recycles its wastewater, or wash your car on your yard so the water infiltrates into the ground.

Septic System

- Inspect your system every 3 years and pump your tank as necessary. (Every 3 years for Doylestown Residents)
- Do not dispose of household hazardous waste in sinks or toilets.

Pet Waste

- Pick up your pet's waste and dispose of it properly. Flushing pet waste is the best disposal method. Leaving pet waste on the ground increases public health risks.

Residential landscaping to manage stormwater

Permeable Pavement - Traditional concrete and asphalt do not allow water to soak into the ground. Permeable pavement systems do allow rain and snowmelt to soak through, decreasing stormwater runoff.

Rain Barrels - You can collect rainwater from your rooftop. The water can then be used later on in the garden or lawn.

Rain Gardens and Grassy Swales - Designed areas planted with native plants can provide natural places for rainwater to collect and soak into the ground.

Standing Up for the Families of Our Fallen Heroes

As a member of the law enforcement community for nearly a decade and a half, I know firsthand the service and sacrifice of our nation's first responders.

In 2016, 229 Public Safety Officers were killed in the line of duty, including law enforcement, firefighters, EMS workers and fire police. While we can never repay those who laid down their lives in the line of duty, we can make it our priority to support their families and their children by increasing federal student aid opportunities for those children who pursue a college education.

That's why I introduced the Children of Fallen Heroes Scholarship Act – bipartisan legislation signed into law by the President earlier this year.

My new law increases the amount of Pell Grant money available to students who are the children of fallen first responders.

My bill was supported by the Fraternal Order of Police, International Association of Firefighters and Pennsylvania Fire Police Association, and I am proud to finally see it become law.

There were 6133 bills mailed and 132 were returned to me as undeliverable as determined by the post office. Here are a few things to help make the tax collection process more efficient:

- Return the "Tax Collector Copy" portion of the bill. (Don't send just the very top of the bill)
- Make the check out with the current date and for the correct amount both in the number field and the written line. (Don't post date checks)
- If you would like to affix your payment, please use a paper clip. (Don't staple it.)

I know everyone makes honest mistakes occasionally so please include your contact information on the back of the bill so I can easily reach you to correct them.

Reducing Hurdles to Health Care

Waiting. It's an undeniable frustration, especially in health care. We're waiting in our homes, in our doctors' offices and in our pharmacies for procedures or medications to be approved by insurance companies. Many patients are familiar with the pre-authorization process, which occurs when medical practitioners must contact the patient's health insurance company to determine if the cost of a test, procedure or medication will be covered.

This waiting for a pre-authorization causes added stress for the patient, administrative time on the part of the physician's office, and most importantly, the potential of delay of diagnosis or care. One Pennsylvania physician brought to my attention that he indicated on a person's death certificate that the cause of death was waiting for a pre-authorization approval from an insurance company.

I understand that among the cost drivers in the health care system are unnecessary tests and medications. As vice chair of the House Insurance Committee, I am committed to addressing cost-drivers in the system.

There is a place and a need for prior authorizations, but the process needs to be standardized to keep the focus on appropriate, timely medical care.

That's why I sponsored House Bill 1293, which would standardize and streamline the pre- authorization process for medical services. In doing so, my legislation would develop a standard prior authorization form that can be electronically submitted by all health care providers and accepted by all health insurers. This bill would also improve transparency and consistent application of prior authorization criteria.

To demonstrate the need for this bill, I'm asking anyone who has had their health care compromised by a preauthorization requirement to share their story with me. You can reach out to me at mquinn@pahousegop.com or call my office at (215) 489-2126.
