

PARKS & RECREATION 2011 FEE SCHEDULE

Excerpted from the Doylestown Township 2011 Fee Schedule

APPROVED – JANUARY 3, 2011

AMMENDED – FEBRUARY 15, 2011

Note: Facilities may not be rented and/or used for the purpose of private gain. Private instruction of any type will result in forfeiture of permits without refund. Use of any facilities for programming other than offered through the Department of Parks and Recreation is prohibited.

General Use Rentals:

- **Central Park Pavilion***

- * Rented in time blocks listed (9am-noon, 1pm-4pm, 5pm-dusk, 9am-2pm, 3pm-dusk, 9am-dusk)
 - * Does not include access to indoor concession area.

Sound Amplification Waiver (placement as directed by township)
 * Contained within space (i.e., D.J. in a pavilion) \$ 45 per day
 * Projected outside of contained space (i.e., Band, concert) \$100 per day

Tent/Inflatable Authorization Waiver (Placement as directed by township) \$ 25 per day / location

Electric (time in to time out) \$ 5 per hour

- **Activity Center** (excluding kitchen access) \$ 75 (first 4 hours)
\$ 15 (each addl. hr.)
 Security Deposit (required) \$100/per day
 Activity Center Kitchen Access* \$ 25 (first 4 hours)
 * Does not include use of supplies or appliances \$ 10 (each addl. hr.)

- **Bridgepoint Park** (special Event Application required)
 Grounds \$250 (first 4 hours)
\$ 40 (each addl. hr.)
 Security Deposit (required) \$100/per day

- **Central Park Lighted Facilities** (first come, first served basis)
 Tennis Courts (coin operated) \$ 2.00 per hour
 Basketball Courts (coin operated) \$ 2.00 per hour

General Use Rentals (cont):

- **Courts/Fields (general public - single use)**

More than 4 hours

Kids' Castle Group Visits (all groups)

Tuesday, Wednesday, and Thursday, from 10 am-3 pm, no Exceptions are made to this policy. All organized groups (I.e., Schools, camps, scouts, day care, organizations, etc.) regardless of size must be pre-registered and make payment in full upon arrival.

- Resident based (located within the township boundaries) \$ 3.50 per person
(excluding chaperones)
- Non-Resident based (located outside township boundaries) \$ 4.00 per person
(excluding chaperones)

External Special Events (runs, walks, tournaments, concerts, etc.)

Requires the submission of a Special Event Application form; additional fees may be applicable (i.e., pavilion, fields, etc.) depending upon the nature of the event and activities proposed. See individual fees under *General Use Rentals*.

- Special Event Application Fee (not waived) \$ 25 (non refundable)
- Security Fee (subject change depending on activities proposed) \$500 per event minimum
- Standard Event Fee

- Sound Amplification Waiver (placement as directed by township)
 - * Contained within space (i.e., D.J. in a pavilion) \$ 45 per day
 - * Projected outside of contained space (i.e., Band, concert) \$100 per day

- Tent Authorization Waiver (Placement as directed by township) \$ 15 per day / location
- Electric (time in to time out) \$ 5 per hour
- Showmobile Rental (limited to Central Park Only) \$ 100 per hour
(Refer to Showmobile rental policy for specific requirements as additional fees may apply)

- Township Support Staff
As deemed necessary and required by the Township relative, but not limited to onsite staffing, setup, Tear-down, post-event cleaning, damage repair, etc. Fees will be assessed accordingly.
 - Weekday (Monday - Friday, 7:30-3:30 pm) *Current pay rate (straight time)*
 - Weekday Evening & Saturdays (4-hour minimum) *Current pay rate (time and a half)*
 - Sundays/Holidays (4-hour minimum) *Current pay rate (double time)*

- Police Support/Assistance (as required by the Police Department) *Current pay rate*

- Facility/Field Restoration (due to misuse, damage, etc.) *Costs incurred by the Twp.*

Seasonal/Recurring Athletic & Sport Uses

Note: *No permitted user may rent, sublet or authorize use to any other individual, group or enterprise for any purpose. Failure to comply will result in permit forfeiture.*

Seasons: *Spring (April 1-June 30), Summer (June 1-Aug. 31), Fall (Sept. 1-Nov 31)*

Seasonal Athletic Field Use (game and/or practice)

Central Park / Turk Park / Sauerman: Athletic Organization League Play and/or recurring group uses. Games and/or practice as per approved schedule. No one season is to exceed 13 weeks or additional fees will apply. Tournaments require separate application/permit.

- Weekly Usage
 - One day per week \$300/field/season
 - Two days per week \$399/field/season
 - Three days per week \$499/field/season
 - Four days per week \$599/field/season
 - Five days per week \$699/field/season
 - Seven days per week \$799/field/season
 - Each additional week over 13 weeks (excluding make-ups) \$125/field/week

- Security Deposit (required) \$500/season
- Facility/Field restoration due to excessive misuse, damage, etc. *Costs incurred by the Township*

Seasonal Use: Non-Field Amenities (courts, park grounds, etc.)

Seasons: *Spring (March 1-May31), Summer (June 1-Aug. 31), Fall (Sept. 1-Nov 31)*

Athletic organization league play/games and/or regular/recurring group uses. Games and/or practice as per approved schedule. No one season is to exceed 13 weeks or additional fees will apply. Tournaments require separate application/fee. Fees based upon one day per week

Basketball Courts (does not include lights)	\$499/court/season
Tennis Courts (does not include lights)	\$399/court/season
Bocce Court	\$299/court/season

Each additional week over 12 weeks (excluding make-ups) \$175/court/season

Less than 4 hours	
Basketball Courts (does not include lights)	\$299/court/season
Tennis Courts (does not include lights)	\$249/court/season
Bocce Court	\$170/court/season

Each additional week over 12 weeks (excluding make-ups) \$ 29/court/season

- **Park Grounds (non field/court)**
 - Cross Country Practice (up to 10 weeks) \$200/location/season
 - * Limited to one day per week
 - Cross Country Meet \$75 per day

Seasonal Athletic Special Use - Tournaments

Available to those seasonal use organizations holding a seasonal game/practice permit: Submission of a Special Event Application is required. An Assembly Permit may be required from the police department.

- Application Fee (submitted with application) \$ 25 (non refundable)
- Athletic Fields (2 consecutive days) :
 - Two Fields \$399
 - Three fields \$599
 - Additional Fields \$ 99 per field/day
- Athletic Fields/Courts - Daily Use (full day - more than 4 hours)
 - Soccer/Football/Baseball/Softball \$159 per field
 - Basketball Courts (does not include lights) \$ 69 per court
 - Tennis Courts (does not include lights) \$ 69 per court
 - Bocce Court \$ 39 per court

- Athletic Fields/Courts - Daily Use (half day - less than 4 hours)
 - Soccer/Football/Baseball/Softball \$ 99 per field
 - Basketball Courts (does not include lights) \$ 39 per court
 - Tennis Courts (does not include lights) \$ 39 per court
 - Bocce Court \$ 29 per court
- Central Park Pavilion \$ 80 per day
(Required if requesting two or more athletic fields-Central Park)
- Sound Amplification Waiver (placement as directed by township)
 - * Contained within space (i.e., D.J. in a pavilion) \$ 45 per day
 - * Projected outside of contained space (i.e., Band, concert) \$100 per day
- Tent/Inflatable Authorization Waiver (Placement as directed by township) \$ 25 per day / location
- Electric (time in to time out) \$ 5 per hour
- Security Deposit (subject to increase based upon nature of events) \$500 per event
- Facility/Field restoration due to misuse, damage, etc. *Costs incurred by the Township*
- Township Support Staff
