State Continues Fight Against Drug Addiction

For many years, it was assumed drug addiction was a problem that happened elsewhere. No more.

Drug overdose is now the leading cause of accidental death in the Commonwealth, outpacing car accidents for the first time in generations. In 2015, 3,383 Pennsylvanians – or nine people statewide each day – died from drug overdoses, the bulk of which came from heroin or its opioid cousins. Locally, 117 people lost their lives – 73 percent of whom had opioids present in their systems.

The abuse of opioid painkillers, like OxyContin and hydrocodone, is directly linked to the heroin epidemic. Patients who sustain debilitating injuries can become dependent on prescription painkillers as tolerance increases. Once patients reach a point where doctors believe higher doses are unsafe or unwarranted, they often turn to the street, where chemically-related heroin is abundantly available at relatively low prices.

The Legislature is taking action to prevent drug addiction and assist those who need help recovering. We're meeting in special session this month to adopt proposals aimed at reducing the supply of prescription painkillers, largely through physician education and the adoption of evidence-based best practices for pain management.

In August, the four policy committees from the House and Senate caucuses joined forces to hold hearing statewide to hear from experts and members of the public about steps that can be taken. One such hearing took place on Aug. 15, at the Doylestown Health and Wellness Center in Warrington. This joins with other local outreach efforts, including a drug forum I hosted last year at the Bucks County Intermediate Unit.

Methamphetamine, a highly addictive central nervous system stimulant, is also a problem in our area. The drug is produced when pseudoephedrine, an ingredient found in common cold medicines, is mixed with other household chemicals.

A 2013 law I introduced created a computer database to track sales of pseudoephedrine-containing products. When legal purchase limits are exceeded, law enforcement is notified, and retailers "stop sale." A recent report detailed the dramatic results of this new law. In 2015, the new system blocked the sale of 100,800 boxes of such products, preventing 266,346 grams of the drugs from being used to manufacture methamphetamine.

Got Milk----weed?

We may not be able to identify a single other butterfly but virtually everyone knows the Monarch. The same is true for the Milkweed plant. Anyone who grew up playing with the pods, releasing the little parachutes of seed, knows what Milkweed is. And, it turns out, these two pieces of nature; the Monarch and the Milkweed, fit together like a hand and glove.

To Monarchs, the Milkweed is absolutely essential. They lay their eggs exclusively on a Milkweed plant. Similarly, the caterpillars will feed only on Milkweed. Adult Monarchs nectar at the Milkweed flowers.

Monarchs migrate. They move from winter hibernation in Mexico or California to as far north as Canada. There is a program for school kids called Journey North, which has enlisted schools in Mexico, the United States and Canada to keep track of the first sightings of Monarchs in their area. Many have set up butterfly gardens at their schools so that the Monarchs will be easier to spot. Naturally, the Milkweed plant is essential in such a garden it forms the "highway" for Monarch migration.

It could not be easier to add this versatile, wildlife-friendly plant to your garden. Here's what I tried. In the fall, find a burst pod of Milkweed with some of the parachutes still in it. Remove them and "dust" them over a sunny area where you'd like Milkweed to grow. Then, cover with the barest amount of soil—just enough to keep the seeds down. No soil amendment is necessary. Keep moist and next spring, you'll be sitting pretty, waiting for butterflies to arrive

If foraging is not your thing, you can get free yes, free—seeds from Live Monarch.com. Their website has a lot of information.

FOR INSTANCE - As most now know, the DTMA recently found one of its fourteen groundwater wells to be contaminated by unregulated perfluorinated compounds (PFC's). DTMA, in consultation with the Pennsylvania Department of Environmental Protection (DEP), immediately shut down the contaminated well which is located in the Cross Keys area. No other public wells in the DTMA system are impacted by the substance. DTMA has maintained an alternate source of supply, for the Cross Keys system, via an inter-connection with its neighbor Doylestown Boro. Because of this redundancy, the transition of moving from one source of supply to another was seamless for users of the Cross Keys water supply when the well was shut down. But this isn't an easy end to the story. The DTMA has no other back up source for the Cross Keys area.

WHAT WE ARE DOING - A one mile cone of influence around the Cross Keys well was established and is now identified by DEP as an area in which it is sampling adjacent private wells in order to see if the contaminant is wide spread within the Cross Keys area.

The one mile cone of influence includes portions of Buckingham, Doylestown and Plumstead Townships as well as Doylestown Borough. Sampling for approximately 400 private wells was started in late July, 2016 and results are pending at time of writing this article. In the interim, DEP has suggested property owners find a safe source of supply, such as bottled water, that can be used for consumption and cooking until results of their testing program are known. Should the contaminant be found in those private wells at levels in excess of the health advisory limit of 70 parts per



All the soap, scum, and oily grit runs along the curb. Then into the storm drain and directly into our lakes, streams and into coastal waters including the Chesapeake Bay. Septic Management: Have you Complied?

In 2001, Doylestown Township passed ordinance No. 299. Per this ordinance, any resident with an on lot disposal system (septic system) must have the system inspected and pumped every three years by a township approved pumper/hauler.

These pumper/haulers will then send a report to the township of their inspection. The township keeps records of these documents.

In addition to septic tank pumping, residents are required to have their well water tested every three years. This assures that fecal coliform contamination has not occurred. If there is fecal coliform detected, there may be additional steps required. Unlike the septic companies, water testing labs will not send this information directly to the township. For this reason, it is the resident's responsibility to bring a copy of their water test in for their records at the township.

Throughout the year, current cycle residents will receive an introduction notice to the program, a reminder post card to fulfill the septic management program requirements by the end of the year, a 30 day non-compliance notice and finally, a civil complaint notice if requirements have not been met. Please pay attention to these notices as they inform residents of when pumping, inspecting and water testing is required.

Septic reports occasionally do not make it to the township building. If you receive a letter reminding you of your requirements for this program but you believe they have been completed, do not fret. Please resend your information to the township so they have the most current records. For more information on this program, visit our website at www.doylestownpa. org/information/septic-management. The below information shows the dates each cycle is due to have their septic system pumped and inspected as well as their well water tested.

Cycles:

Cycle 1: 2016, 2019, 2022, 2025... every three years Cycle 2: 2017, 2020, 2023, 2026... every three years Cycle 3: 2018, 2021, 2024, 2027... every three years



Congressional Update

The work of the Congress continues through all seasons with scores of issues on the table: Domestic, international, security, economic, social and health. I am sure you have read about the devastating increase in heroin and prescription opioid abuse in communities across the country. Tragically, drug overdoses surpass auto accidents as the leading cause of injury-related deaths for Americans ages 25 to 64. It is a tragedy that deserves everyone's attention.

The House passed, and the President signed, the Comprehensive Addiction and Recovery Act, or CARA, as one major step in addressing this growing challenge. Notably, the bipartisan legislation was developed over the last two-and-a-half years, ultimately providing the necessary tools to our law enforcement officials, caregivers and others.

While this law is a comprehensive approach to combating America's opioid epidemic, it's one piece of the puzzle. There is no substitute for the role of the family in preventing prescription and illicit drug use. For more information, please visit my website: www.fitzpatrick. house.gov/epidemic

I recently co-sponsored two pieces of legislation regarding man's best friend. One extends their potential to assist our veterans, while the other ensures the safety of the dog, along with the safety of their owners.

H.R. 4764, Puppies Assisting Wounded Service Members (PAWS) Act of 2016. This bill would allow the Department of Veterans Affairs to provide service dogs for veterans suffering from Post-Traumatic Stress Disorder. Service dogs may offer multiple solutions to medical and psychological problems, according to the Dept. of Defense.

The safety of those most vulnerable to violence and without adequate protection also is a priority. H.R. 1258 Pet and Women Safety Act of 2015 to protect the pets of victims of domestic and dating violence. The aim of H.R.1258 is to further codify the law to protect pets and their owners from forms of assault and violence.

During the past two years, I was privileged to chair the House Task Force to Investigate Terrorism Financing. After a series of hearings from expert witnesses, the House passed bipartisan legislation to strengthen our national strategy to combat terrorism financing. It cannot be emphasized too often:

Please remember that although your pumper hauler will send us a copy of your pumper's report, it is the homeowner's responsibility to send a copy of your water test results to the Township. We are located at 425 Wells Rd., next to Central Park. If you have your water test done at the Bucks County Health Department, it is located on Almshouse Road. They do not forward us a copy of your water test.






