Chairman's Message By: Barbara N. Lyons

Each year the supervisors and the township manager attend the Pennsylvania Association of Township Supervisors (PSATS) education and trade show conference. We learn about the newest technology in road surfaces and playground equipment, recent land use and zoning issues, traffic calming, police and public works administration. We bring this information back to our township.

One fact I learned several years ago at one of the first conferences I attended is that the Doylestown community produces more volunteers than any other in the Commonwealth. Our Township stands out among the 1,450 Township Communities of similar size, as having more volunteers engaged in the business of township government.

I started out as a volunteer over 20 years ago with some folks who still give their valuable time to the Township: John Bray in Parks and Recreation, Kathy Brown in the Dog Park, Tom Kelso on the Bike and Hike committee, Rick Colello who, like me, went on to become a supervisor, and many others, like George Lowestein the most recent recipient of the Unsung Hero Award.

Over the years, volunteers have helped build Kid's Castle, 25 miles of trails, the native species garden, amenities in the park and the environmental education area in Central Park. Township residents are members of the Planning Commission, Zoning Hearing Board, the Environmental Advisory Council, the Telecommunications Advisory Board, the Traffic Committee, the Ways and Means Committee and the Park and Recreation board, just to name a few.

Most of the work done in the Township, with the exception of financing, policing and public works, have hands on help from resident volunteers, who





## New Laws Honor Service of Pennsylvania's Veterans, Military Personnel

Pennsylvania boasts a rich tradition of military service that dates back to the Revolutionary War in the 1700s. Throughout our nation's history, Pennsylvanians have answered the call to serve in large numbers and helped turn the tide in some of the most decisive conflicts of the past three centuries. Both the quantity and quality of the men and women who have served in the military is a point of pride for our entire state.

Whiletheincredibleserviceofourmilitarypersonnel is deeply appreciated by a grateful Commonwealth, far too often our men and women in uniform come home from combat to face new battles in finding steady employment and managing household finances. Military families also often struggle with the burdens of having a member of the household deployed for long periods of time.

In recognition of the challenges facing our service members and their families, lawmakers have taken a number of important steps to honor the sacrifices of our military and veterans and ensure their basic needs are met.

Earlier this year, I supported the creation of a new law that exempts active duty military pay from the Earned Income Tax in order to lessen the tax burden on military personnel. I also supported a new law that provides in-state tuition rates at community colleges, state-owned colleges and state-related universities for veterans, their spouses and dependent children.

Finding employment after separating from military service is often a challenge, particularly as communities throughout the state are still struggling with underemployment following the recession. A new law aims to improve veteran employment opportunities by ensuring that a service member's military education and training are taken into consideration for the purpose of fulfilling requirements for professional credentials, including licensing and certification requirements.

In addition, lawmakers recently authorized the creation of a new "Honoring Our Veterans" license plate for motorcycles. A portion of the funds raised through sales of the new plates is dedicated to the Veterans Trust Fund to assists veterans in need.

In order to provide additional assistance to military personnel and their families, the Military Family Relief Assistance Program was also recently expanded. The program provides grants of up to \$3,500 to eligible Pennsylvania service members and their family members who have a direct and immediate financial need as a result of circumstances beyond their control. The eligibility guidelines were expanded to allow more families in need to qualify. More information on the program is available online at www.mfrap.pa.gov.

## Resident Sign up for "Ready Bucks" Emergency Notifications

It is recommended that every resident sign up for ReadyBucks, the Emergency Mass Notification system operated by Bucks County. When you take advantage of this free sign up you will be alerted about emergency situations including severe weather, flooding, gas leaks, police activity and other important community notifications.

You can create an account by accessing the link on the Emergency Management page of the Township website, or going to buckscounty.org/ReadyBucks. It only takes minutes to subscribe. You can choose to get alerts on any of your devices and mobile apps are available. You can also choose who you want to receive alerts from and what type of alert. If you work in one location, but live in another you can choose alerts from both locations. If you have family at school, you can also opt in for messages from that location.

When signing up for an account, you are given the option to use a quiet time feature which allows you to choose the times at which you do not want to receive messages. However, under certain circumstances where an immediate threat to health or safety is imminent the quiet time feature can be overridden for your safety.

Our recommendation is that every Township resident should sign up for ReadyBucks so that in the event of an emergency the Township is able to contact you. If you are not signed up, you will not receive urgent information from your Township or County that may affect the safety of your family.

## Tax Amnesty, HB1888

At any given moment, the Commonwealth is owed between \$1.5 billion and \$2 billion in back taxes. A portion of these dollars has been delinquent for years, and the likelihood of successfully collecting many of these outstanding payments is low.

Given these difficult budget times, it makes sense to explore every available opportunity to collect this outstanding revenue. One option that has proven successful in the past is known as "tax amnesty."

I have introduced legislation (House Bill 1888,) which would establish a tax amnesty program in Pennsylvania for the first time since 2010 – the last year it was implemented. The legislation would permit individuals who owe back taxes to the state to come forward and file tax returns in exchange for reduced interest on unpaid taxes, reduced penalties and, in some cases, limiting the number of years one must go back to pay delinquent tax bills.

It's not unlike what occurs when individuals settle a debt with a collection agency or credit card company. During such deliberations, interest and fees can be reduced or waived, while a payment plan can be negotiated to recover dollars that otherwise would be lost.

Let me be clear: Tax amnesty would not let those who fail to pay their taxes off the hook. However, it would offer positive incentives to make settlements on accounts that otherwise would go unpaid. With a structural deficit facing our state of nearly \$1.8 billion, every tax dollar collected is one less dollar that won't need to be raised elsewhere or transferred from a worthy program.

The 2010 Pennsylvania tax amnesty program was considered a success. One million businesses and individuals with outstanding tax bills were contacted, and 60,000 took advantage of the amnesty program. During the 54-day window, more than \$250 million was collected for the state treasury. This far exceeded any expectations and continued to generate additional revenues into the next fiscal year.

NOTICE FIRE HYDRANT FLUSHING

## THE DOYLESTOWN TOWNSHIP MUNICIPAL AUTHORITY

Is conducting its Annual Fire Hydrant Flushing Program of its Water System.

Flushing will continue potentially into July.

Keep an eye out for updates on the next round of hydrant flushing.

All hydrant flushing is weather permitting

Flushing will be done between the hours of 6:30AM – 3:30PM

Flushing consists of opening fire hydrants to maximize water flows. Turbulence within the water mains occurs and while you may not see us flushing in your area, any portion of an area can be affected. Time should be allowed for this turbulence in the water mains to settle. If you notice discolored water from your tap(s), run the cold water until clear and refrain from washing clothes until the water is clear. Water system pressure can be reduced during flushing. The water pressure will return to normal when flushing is complete.

## Why do you flush the water system?

We flush the system to remove settled particles such as iron from the system. This helps to reduce discolored water in the system. This also allows the Water Operators to inspect and perform maintenance on the fire hydrants.

### How often do you flush the water system?

We flush the water system twice per year; each spring and fall.

### Is there any particular time you flush the system?

Yes. We flush from 6:30 a.m. to 3:30 p.m.

## **Reaching Out**

August 25, 2016, marks the centennial of the National Park Service and its 58 national parks, from Acadia National Park in Maine to Zion National Park in Utah. We are fortunate indeed, to live in a nation and a county blessed with natural beauty and thoughtful leaders committed to conservation and preservation.

This commitment is an integral part of any plan designed to maintain our quality of life, our resources and passing them along to the next generation. Conservation of our natural resources remains a high priority in the nation's capital, highlighted as it is on the 100th anniversary of our national park system.

Many of us in Congress believe that natural resource conservation is a goal that transcends partisan politics. I have been a staunch advocate, believing it should be a unified goal for all Americans and have addressed this by joining with Republicans and Democrats on the conservation issues championed by the Land and Water Conservation Fund.

For more than 50 years, the LWCF has been the leader in protecting our national parks, wildlife refuges, forests and wilderness areas, as well as state and local parks, working forests, critical wildlife areas and Civil War battlefields – at no cost to taxpayers. Funding for LWCF comes from a portion of the royalties oil and gas companies pay to drill in federal waters.

LWCF was "allowed" to lapse for the first time in history last year. But Congress took action by providing a three-year fund extension. I introduced legislation with 200 co-sponsors in the House of Representatives and 18 in the Senate in support of permanent reauthorization.

I believe it is most important to support educational initiatives and existing programs with successful track records on conservation and environmental protection and advocated legislation (that passed) intended to boost students' environmental literacy by strengthening environmental education in the schools.



Finally, keep in mind the importance of environmental preservation and conservation, today, so future generations also may enjoy the benefits of the vast natural beauty of our country and our county.

## **Using Green Infrastructure**



Stormwater washes over the top of impervious surfaces, picking up pollutants, trash, sediment and other contaminants as it goes. This virtual water slide of toxins empties into the nearest water body causing pollutant levels to rise. How can green infrastructure help reduce this effect and improve water quality and quantity at the same time?

According to the EPA's Benefits of Green Infrastructure page, green infrastructure such as rain gardens, rain barrels, green roofs and countless other infrastructures retain water from storm events, preventing the water slide effect. This means lower pollutant loads as the water properly drains through the ground. This slowing and reducing of stormwater also lessens flood risks as the water can absorb into the ground.

The page goes on to explain that these types of structures also help the water supply as rainwater can be collected during storm events and used for activities such as gardening. Water that is absorbed recharges ground water. This is an important part of the hydrological cycle, seen below, a driving force behind a source of our water supply.


The EPA says using green infrastructure can reduce cost both privately and publicly. Developers who use green infrastructure find lower capital costs in projects. These savings come from site grading, paving, and landscaping as well as smaller or eliminated piping and detention facilities. In cities, green infrastructure costs less than conventional controls of gray infrastructure. Gray infrastructure refers to controls for water that people might normally think of, like pipe drainage and water treatment plants. Mixing gray and green infrastructure may have the benefit of reducing public expenditures on stormwater infrastructure as green infrastructure is less costly and still effective.

The goal achieved through these donations is a new play environment at Kids Castle that welcomes children of all abilities including those with sensory processing disorders, autism, and people of all ages using wheelchairs and other mobility devices.

While play is an important part of children's developmental needs, it has to be fun enough for them to want to be part of the experience and the ongoing improvements at Kids Castle will provide that opportunity for all children.

As part of our plan, when the funds are raised we will also be adding a new shock absorbing safety surface throughout the playground called poured-in-place which is used to form a unitary surface.

This type of surfacing makes it easier for wheelchairs, people using other mobility devices and strollers to enter and navigate in the play-space, unlike engineered wood fibers or other loose materials.

To achieve these goals, we are actively pursuing grants, ongoing donations and sponsorships so we can add these new play pieces and create this Inclusive play environment.



While we are making progress, we can only continue forward with your financial support.

## On the Road: Public Works Update

Our road department is at it again! The Township contracted with the firm of James D. Morrissey, Inc., to mill and pave approximately 4.6 miles of township roads in April. Preparatory to mill and pave, the Road Crew was active in making repairs to the road base, drainage systems and ADA ramps on the following roads: Charter Circle, Settlers Drive, Chestnut Valley Drive, Meetinghouse Road, Sandy Knoll Drive, Pine Mill Circle, Spring Valley Road and Wells Road.

Other drainage work is scheduled for the areas of David Way, Old New Road and Springs Drive during the summer months. Work consists of replacing existing drainage pipe and stabilizing eroded grass swales.

Other work consists of street tree pruning and/or removal and will be completed by a qualified pruning contractor during the summer/fall months along various road ways and park lands.

## **Doylestown Township Stormwater Hotline:**

Question: What is the Doylestown Township Stormwater Hotline?

Answer: A way for residents to report illicit discharge they may see in the Township.

Question: What is Illicit Discharge?

Answer: Illicit Discharge is any chemical or item other than water that is poured into a storm drain. This can include oil, grey water, paint, etc.

These items affect water quality and environmental health. As part of our stormwater management program, Doylestown Township encourages its residents to use the Stormwater Hotline as a means of reporting contaminants so they can be attended to accordingly. To report a potential issue, call 215-348-9915.

## In the Parks: Project Updates

The Park Maintenance staff will be closing out the construction of the Sensory Trail in Central Park during April/May, 2016. The trail consists of nine pods with nine different play experiences for people with sensory needs. The approximately nine hundred foot asphalt trail adjacent to the new athletic fields, leads from the New Britain Road parking area to a point entering the Central Park woodlands and exits at a point of return to the parking lot.

They do not forward us a copy of your water test.
