
### **Current Status of IDD&E**

- Year 19 of the Program
- GHD completed typical hot spot IDD&E sampling
- GHD Collected 23 samples from Hot Spots
- Doylestown Township remains in compliance
- New Permit received in December 2019. Good for 5
  years until November 2024
- September 2023 Next PADEP MS4 report due





### **IDD&E – Dry Weather Inspection**



### **IDD&E Inspections, Sampling & Results - 2021**

- Focused Inspections & Sampling
  - Historical Hot Spots (Areas 1, 2, and 3)
- Sample Analysis Fecal Coliform (FC) at all locations with flow
  - Area 1 11 inspections / 11 sampled
  - Area 2 9 inspections / 9 sampled
  - Area 3 3 inspections / 3 sampled
- Data Review Chose 5 locations (Areas 1, 2, & 3) for DNA fingerprinting
  - 7th year of DNA sampling
  - 5 samples per year since 2015
  - In 2021, 5 Outfalls re-sampled for FC plus DNA based on the 5 highest FC readings during the 1<sup>st</sup> round of sampling





# **DNA Fingerprinting**

DNA Tests 2021

- DNA
- Goose (0 indicator tests)
- Cow (0 indicator tests)
- Ruminant [e.g. deer] (1 indicator tests)
- Dog (2 indicator test)
- Human (4 indicator tests)





## **IDD&E Sampling - 2020**

### Area 1 – 11 Inspections

- 11 samples
- 1 sample FC >200 col/100 ml
- Maximum FC = >6,000 col/100 ml
- DNA testing (2 samples)
  - 1 positive for Human
  - 1 positive for Dog





## **IDD&E Sampling - 2020**

#### Area 2 – 9 Inspections

- 9 samples
- 1 sample FC >200 col/100 ml
- Maximum FC = 320 col/100 ml
- DNA testing (3 samples)
  - 3 positive for Human
  - 1 positive for Ruminant
  - 1 positive for Dog

## **IDD&E Sampling - 2020**

### Area 3 – 3 Inspections

- 3 samples
- No samples >200 col/100 ml
- Maximum FC = 60 col/100 ml
- No DNA samples collected

### IDD&E Sampling – 2016 through 2021

#### Area 1

2016 - 2 >200 col/100 ml 2017 - 5 >200 col/100 ml (Max = >600) 2018 - 5 >200 col/100 ml (Max = 3,200) 2019 - 7 >200 col/100 ml (Max = >600) 2020 - 2 >200 col/100 ml (Max = 1,800) 2021 - 1 >200 col/100 ml (Max = >6,000)

#### Area 2

2016 - 5 >200 col/100 ml (Max = 1,700) 2017 - 7 >200 col/100 ml (Max = 600) 2018 - 5 >200 col/100 ml (Max = >6,000) 2019 - 2 >200 col/100 ml (Max = 600) 2020 - 4 >200 col/100 ml (Max = 3,000) 2021 - 1 > 200 col/100 ml (Max = 320)

- Area 3
- 2016 No FC >200 col/100 ml
- 2017 1 >200 col/100 ml (Max = 2,200)
- 2018 1 >200 col/100 ml (Max = 240)
- 2019 No FC >200 col/100 ml
- 2020 No FC >200 col/100 ml
- 2021 No FC > 200 col/100 ml





## **IDDE Mapping - 2021**

- GHD used the Township's mapping tool from CSDatum to map, photograph and document the inspections in 2021.
- This tool allows GHD to automatically update the township storm water map, input the data collected in the field in real time, and produce the forms required for their storm water report.
- GHD will continue using this tool for all future storm water sampling and inspections to keep information updated.





# IDD&E – Going Forward 2022

GHD will:

- Continue to GPS outfalls and observation points using CSDatum program, Update Outfall Map
- Complete inspections/Historical hot-spot sampling (Areas 1, 2, and 3) using CSDatum program (~30 locations)
- Complete additional Inspections & Sampling as requested
- Comply with current permit PAG-13
- Preform additional source investigations as needed
  - Dye tracing
  - TV inspections
  - DNA testing





### **IDD&E – Takeaways**

- Township in Compliance
- Continue Inspections/Sampling
- GPS outfalls, Update Outfall Map
- Septic System Maintenance
- Public Participation
- Pollution Prevention and good housekeeping
- Goal is to Improve Water Quality!
