The Doylestown Township Planning Commission reviewed the information at their recent work session and recommends no action or objection is needed, due to the proposed zoning change will not impact the Township directly.

Pileggi, Jr's request to re-zone approximately 41.2 acres of land from Residential Agriculture (RA) to Institutional Age qualified Residential District (IUA). ## E. Supervisors

Mr. Touhill announced the Environmental Advisory Council and Park & Recreation Board will be presenting their year end reports at the Board of Supervisors regular meeting in February.

Mr. Snyder reported during the recent Building Renovation meeting, space requirements were discussed. The goal is complete the project without high cost in labor. The next step is to receive new estimates to compare with ones previously submitted. The committee is also preparing a presentation for the Board of Supervisors on February 2, 2016. The next building renovation meeting is scheduled for Thursday, January 21st at 2:00pm.

The Ways and Means Committee will hold their reorganization meeting on January 27th at 7:00pm. The committee will also be reviewing the 2016 budget process, so they may improve on the budget process and incorporate changes in 2017. Mr. Snyder encouraged all supervisors and Finance Director; Ken Wallace to attend.

Mr. Colello reported Chairman of the Doylestown Township Municipal Authority (DTMA); Ronald C. May announced his resignation effective February 19th after nineteen years of service. Mr. May delayed his resignation to provide sufficient time to locate his replacement.

Mr. Colello made a MOTION; seconded by Mr. Touhill the Doylestown Township Board of Supervisors accept the resignation of Ronald C. May as Chairman of the Doylestown Township Municipal Authority Committee effective February 19, 2016.

Mr. Colello made a MOTION; seconded by Mr. Touhill the Doylestown Township Board of Supervisors appoint Joe Van Houten to the Doylestown Township Municipal Authority effective February 19, 2016.

#### VII. NEW BUSINESS

#### A. BIKE & HIKE EASEMENTS

#### 1. Neshaminy Greenway & Lower State Road

Bike and Hike Committee Member; Thomas Kelso addressed the Board to request approval to move forward with appraisals for two properties. Mrs. Lyons indicated appraisals for the Emmell Property at 159 Almshouse Road is anticipated to cost \$1,300.00 and Fordhook Farms off Lower State Road at \$1,200.00 with an appraisal review of \$1,800 because of the Federal Grant.

Mr. Kelso reported; upon a recent discussion at the Bike & Hike Committee meeting, there is a commitment to continue discussions with each property owner to resolve any issues they may have.

He then noted it's important to submit the appraisals as soon as possible, because of the process time. It will also assist with negotiations.

Mr. Snyder questioned; with the proposed 10 foot wide path causing a disruption with existing trees, has the committee offered any compromises. Mr. Kelso answered; the committee will provide the property owners with three or four different options for consideration.

Mr. Touhill made a MOTON; seconded by Mr. Colello the Doylestown Township Board of Supervisors approve appraisals be performed at the Emmell Property at 159 Almshouse and the Fordhook Farms property located off Lower State Road along with the required appraisal review for a combined amount of approximately \$4,300.00 in connection with the Neshaminy Greenway Trail project and TAP Grant.

### B. Request for Second Driveway - Ewer Property

Ms. Mason reported on Mr. John Ewer of 10 Bedford Drive in Doylestown request to add a second driveway with regards to a new garage construction. As per Director of Code Enforcement; Sinclair Salisbury January 12, 2016 memorandum, there is no objection to Mr. Ewe's request. The construction provides improvement to the property's impervious surface.

Mr. Colello was in favor of the proposed improvement, stating it's a difficult neighborhood to offer improvements, make more livable, comply with the needs of the neighbors and impervious surface.

Mr. Touhill concurred with Mr. Colello's comments and noted for the record, his previous employment with the applicants' family member.

Mr. Colello made a MOTION; seconded by Mr. Snyder the Doylestown Township Board of Supervisors approve Mr. John Ewer's request to build a second driveway at 10 Bedford Drive in Doylestown.
