# IX. Public Comment – All Items

Mr. Lindy, 462 Tallyho Way, stated stakes have been placed in the retention basin and would like clarity on what is occurring. Mr. Tomko stated there is a naturalization program and noted he is working with professional staff to have all his questions answered. He stated the naturalization program will reduce cost, emissions, and create habitat.

Mr. Snyder, 50 Foxcroft Drive, noted he was there to speak on how Ms. Santacecilia`s in-actions are affecting the Township. He stated she did not follow the Supervisors guidelines, especially not serving as a liaison on boards and committees. Mr. Snyder stated she is only doing part of her job and should only receive partial compensation. He noted there has been much time and effort wasted debating her actions over the last five board of Supervisors meetings and the Township has suffered. He demanded Ms. Santacecilia`s resignation.

Mr. Mackouse, Buckingham resident, stated he has fought antisemitism and believes the words against Ms. Santacecilia are politically motivated. He stated it is a defamation of character and spoke on how he feels politically about the education system.
