Destination Peace Valley Bridge – Update

Ms. Patterson reported that they are working on the bridge at Peace Valley. Most of the work has been completed by the contractor. There was an issue, they had to build up the side in the woods and this was asked for by runners, so there was additional soil. Things look good.

Mr. Keslo said that he had been out there and the unpaved portion at the reservoir is not working quite well, there was crushed stone put down to meet the needs of the residents at the early meeting, however, this is not optimal – we have a change order to put some fine crushed stone on top what is there and roll it to make it a little bit easier to ride on.

The committee believed that was the best route and made a recommendation on motion of Mr. Patterson, seconded by Ms. Jacobson. The motion carried unanimously.

Mr. Kelso indicated that the bridge is not quite ready at the time of the bid, because we still needed permits that were not quite ready. The permits have been received. Prices are starting to be gathered, there is discussion right now as the optimal size of the bridge and depth of the pylons will need to be in crossing the bridge.

More information will be forthcoming.

Neshaminy Creek Greenway Trail – Update

Mr. Kelso indicated that it looks like they are ready to pave. They are setting the steel for the bridge over the wetlands. The Township will do the wood decking since it is very low level bridge over the wetland there is not rail required. We may need some volunteers to help, as well.

Soil was put on the edge of the path for runners.

The portion from White Eagle Labs former property is also being put in; it should be done within the next two weeks.

Ribbon cutting is anticipated sometime in October. Perhaps middle of the week, possibly a Wednesday.
