a. **Reviewed in December 2010-** The committee reviewed the Neamond Track Plan. The committee recesses to join the planning commission meeting at which this plan was being reviewed. He agreed that the Phase 1 and/or 2 reports would be useful. The committee decided to send a memo to the planning commission asking for a copy of all environmental documents from the site as well as the Phase 1 and 2 reports. They are also going to ask if they are planning on any further studies of soils, etc and how they will remediate issues if any contamination is found. Mrs. Zadel will prepare the memo and distribute it to the Chair before sending out.
