## **New Business:**

These associates are non-voting members so they do not need to be approved by BOS. Dan Wood was there to happily accept this title. The other two associates named included Marcello and Jeff Schumacher.

## **Unfinished Business:**

Pine Run Reservoir education sign- 5 volunteer meetings were held by Anne, Andrea, Jeannine, Tanya, Tom Price and Jane from New Britain Birdtown. The status of the sign is the mock up is complete, but we are waiting to hear back from the County on approval of the mock up. After this is approved, we will move forward in sending to Boucher and James and paying Harris Brown for his photos. Stephanie said she would contact Kevin Spencer directly to get the sign moving along.

Ash Road buffer planting- Tabled until next meeting.

Proposed revision of Landscape Regulations and Native Plant ordinance- Anne, Heidi and Jeannine have been working on revisions and sent a letter and DRAFT revision to Judy Goldstein, Township Planning Consultant and Judy Hendrixson, planning commission chair. The letter and revision also needed to be sent to Stephanie Mason as she is the one who creates the packet for the meetings to make sure it is discussed and that all parties involved are aware of the potential changes.

Artmoblie- the Artmobile is still up in the air because no solidified plans have made with Kutz elementary. Jeannine mentioned previously that she would contact the new principal. It was discussed that Kutz did not want to commit to April 2019 dates because they did not have their schedule. Now that the school year has started, they have a schedule and should be able to coordinate with the EAC to make reservations.

Sauerman Park- Stephanie said she is waiting to hear from DCNR.

Recycling was brought up. Andrea and Stephanie went to a recycling meeting earlier that day and spoke about the current issues with trash and recycling. The EAC can help by educating the public about recycling and hosting an e-recycling event.

## **Old Business:**

200 Years / 200 Oaks- Marty received two quotes for oak trees. Cole's nursery and Hammell nursery. Cole's nursery gave Marty a quote in 2017 but said he would honor the previously quoted price. His price for delivery was a 400\$ fee. Hammell quoted each tree at \$165.00 x 110 trees = \$18,150 plus \$500 per load for delivery and will probably need 2 deliveries. Stephanie and Anne said they needed to set up a meeting to run the numbers. The price will drive the company used. Marty says they should scope of the area first to see how many of each kind of tree to order. The logistics of the tree planting are still in the works but the EAC is shooting for an October  $13^{th}$  planting date.

Jen spoke about meeting with Sinclair and Stephanie about Green Points with permits. They are working on getting the numbers together and will bring to BOS meeting on October 1<sup>st</sup>.
