 - Kathleen Connolly is the Penn State Extension Bucks County Coordinator
- Dog signage at Covered Bridge Park
 - Tom Price New Britain Borough
 - Sign on our side is not the same as the other side
 - Tom would like us to add graphics to the sign to better display leash requirements
 - Could use the same sign as we use elsewhere
 - Pine Run Reservoir
 - Is it a protected wildlife area?
 - Aaron Walizer will get more history on the ordinance
- New long-term strategic plan
 - Curt Sawyer will produce draft document for next meeting
- o RGGI
 - Background
 - Governor Wolf wants PA in RGGI
 - \circ $\,$ Cap and trade plan $\,$
 - Would work to reduce greenhouse gases
 - PA is the largest emitter in the group
 - Legislature passed resolutions of disapproval (largely on a party line vote)
 - Wolf vetoed Senate bill likely not enough votes to override

- Planned to ask Board of Supervisors to write to our representatives in Harrisburg to support RGGI – in line with RF100 resolution
- Table for now and work with EAC and BOS to support reductions in greenhouse gases
 - Resolution for BOS
 - Jim Baldassare will circulate draft resolution
- Ongoing business and subcommittees
 - Native Plant Demonstration Garden
 - Volunteer work crew the last Saturday of each month March-November
 - New signs at expansion area and basin work area
 - Design of expansion area
 - Path is wood chips and meanders through the area
 - EAC may support native trees and shrubs this year along that path
 - Retention basin remediation
 - Next steps will start up again in Spring
 - Removal of invasives and replacement with native plants
 - Probably March
 - Butler Road project
 - Probably April
 - Agenda item for February to set date
 - Will need some volunteers 1-3 people
 - o Birdtown
 - Organizational meeting 1/25 at 7:00 p.m. (Zoom)
 - Nest watch
 - Plan of action for the EAC in February
 - Possible birding at Fonthill
 - Bonnie Oliver may be a contact
 - 30 species identified at Christmas bird count
 - Possible native plant garden at Fonthill?
 - Single Use Plastics resolution
 - Barbara Lyons is on board with this
 - Would like to put on the BOS agenda for January
 - Heidi will continue to reach out to Ryan Manion
 - Is there a list of restaurants in the Township?
 - Could be useful to visit restaurants to get their perspective
 - Fire Department might have a list of businesses. County may also have a list.
 - Could have some kind of recognition for restaurants that reduce use of plastics.
