#### **Old Business**

• Discussion of Sauerman Rd traffic speed, traffic calming funds and next steps.

- For the 2012 budget working group, traffic committee's capital funds were was cut to \$25,000, based on what was spent this year.
  - \$12,000 were spent this year on traffic counters and the roads department spent some funds (Cynthia, but the details, including the amount, are not available).
- Dennis broached the subject of traffic calming and it's effect. A discussion ensued about the effectiveness of lowering the speed limits and enforcement and the problems with Sugar Bottom Rd (3 municipalities make enforcement difficult).
- Status of web concern form (Dave)
  - Dave has not finished the coding, but expects to this weekend. He will contact Sandra when it is ready.

- The Grasso property (Furlong) and it's effect on Rodgers Rd and the York Rd intersection was discussed. Item was tabled because we don't have enough information to make a decision. They have not respoded to Pennoni's letter indicating they did not meet the requirement for traffic impact.
- Cynthia expressed concerns about the left turn from NB Easton onto Edison-Furlong Rd and asked why there isn't a left turn signal. Dave T will ask PennDOT to look into a warrant for putting in a left turn signal.
- Woodridge Rd, Willow Lane, Westaway Lane resident traffic concerns. (Dave)
  - Dave re-hashed the minutes regarding Woodridge and asked what the next steps are since the counter is showing 11 MPH over the posted limit. Cynthia indicated there are new electronic speed limit signs that are supposed to be installed that will show the driver's speed limit.
  - Kelli Keegan asked about what the next steps are regarding Willow.

- Allen described the process of sending a letter to the neighborhood and enforcement by DTPD.
- Mark S will follow up with Lt. Logan regarding the signs. The Doylestown Hunt letter is in Dave's possession if we need to adapt/recycle it.
