## **Correspondence:**

Mr. Bray noted that the Park and Recreation Department was the recipient of two *Excellence in Programming* Awards for "Howl-O-Ween" and "Harry Potter's Mystical Wizarding Tour". The board members expressed their enthusiasm and congratulated Ms. Sweeney and Ms. Thompson for their hard work.

### Plan Review:

Mr. Bray noted that a Revised Preliminary Land Development Plan had been received relative to the Neamand Tract. The board members concurred.

# **Ongoing Business:**

He further suggested that that the furniture items (game tables and benches need to be finalized so that they can begin fund raising for the items.
