#### **New Business Discussion**

Two trucks are confirmed and additional attendance (at least 2) pending. Also pushing the event on social media. P&R Board encouraged to look into food truck opportunities. Additional games for the event discussed, including promoting disk golf.
- 4. Touch A Truck. Confirmed attendance list reviewed.
- 5. Fitness Wall. Discussion of health and wellness campaign and investigation into opportunities in multiple parks. Greenfields is a specific example.
