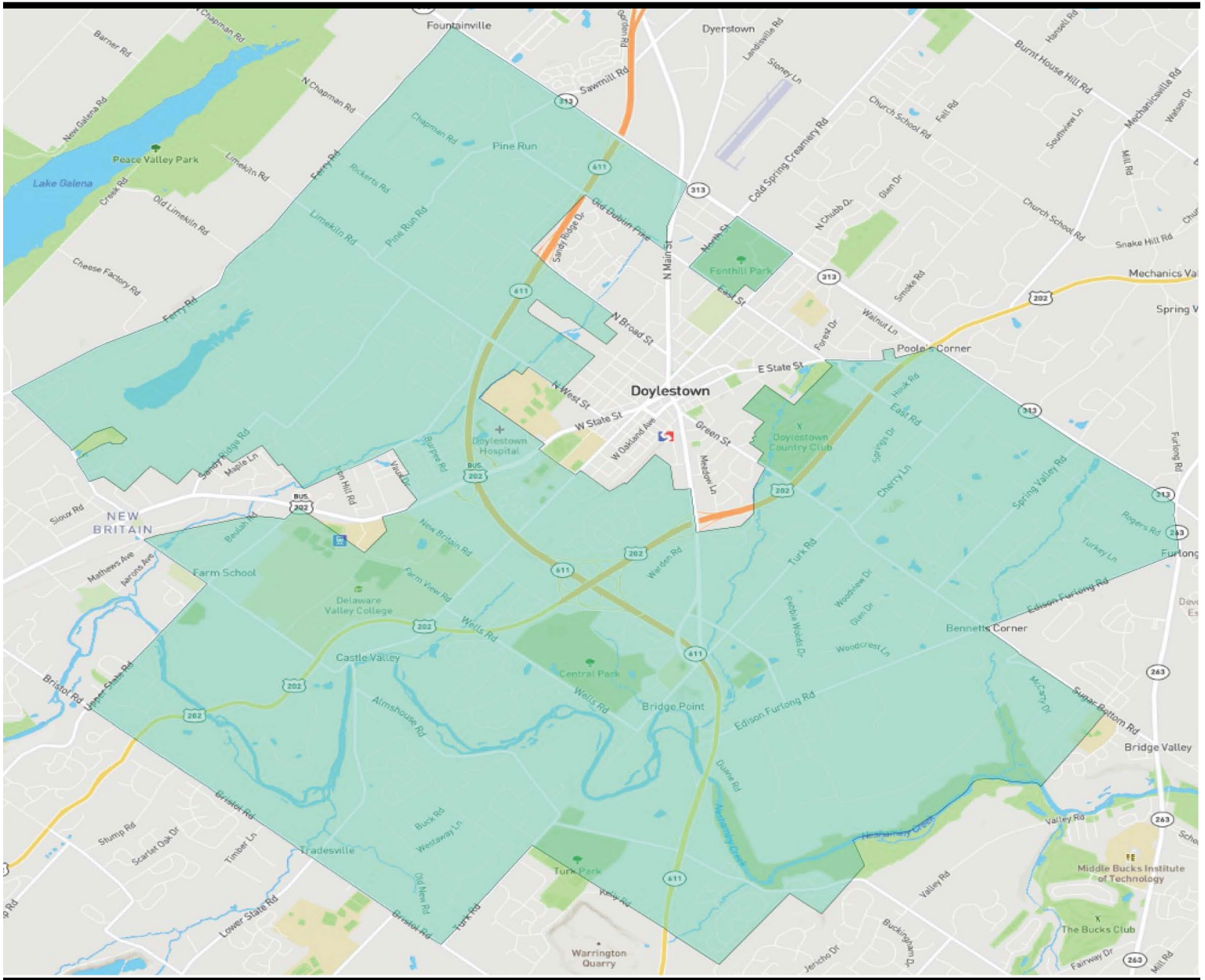

# **New to Doylestown Township?**

## **See the New Resident Requirements!**

Doylestown Township does NOT currently require a Use & Occupancy Permit or inspection for residential resales. This means that our Code Enforcement Office will not be inspecting your property and there are no permit fees involved in the purchase of your new home. However, since we do not require these types of inspections, it can become difficult for us to know when ownership changes. This is why it is very important for our new residents to be sure they have filed a Deed Registration and Move-In Permit with the Township's Code Enforcement Office. ***(Often this is handled by your title company at settlement, so be sure to check with them that it has been completed.)***

### **DEED REGISTRATION**

Doylestown Township Ordinance 218 requires that upon sale of any residential or commercial property, a copy of the new deed is to be registered with the Township using the Deed Registration Form. The fee is \$10. Please submit by mail the form, a copy of your deed, and a check for \$10. *Please check with your title company to make sure this has not already been completed.* Forms can be found on the following pages.

### **MOVE-IN-PERMIT**

Doylestown Township Ordinance Number 258 requires that all those moving into the Township register with the Township using the Move-In-Permit form. Landlords are to register the names and ages of all their tenants that move into their rental properties, and update the information if tenants change. There is no charge to file a Move-In-Permit. 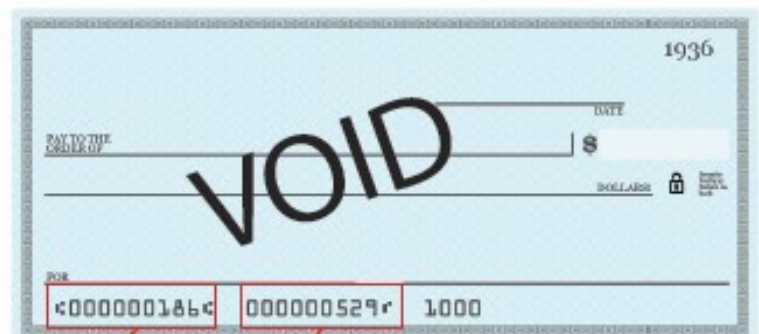

## Septage Management Program

---

### **Doylestown Township Supervisors passed Ordinance No. 299 in 2001**

The ordinance requires all residents who currently have on-lot disposal systems (septic systems) to have their systems pumped and inspected by a Township approved pumper/hauler/installer every three years. The service provider will send us a copy of your inspection report. In addition to a septic system, if you have a private well, it is required that the well water be tested for coliform bacteria (E-Coli) every three years as well. Water testing is not required if you are on public water or public sewer.

### **Why You Need Your Septic System Inspected**

**Protect your property value:** An unkempt septic system can lower your property's value and could potentially cost you in legal liabilities.

**Protect our ecosystem:** Contaminated wastewater poses a threat to our local environment. Malfunctioning septic systems can disperse bacteria and toxins to our natural waterways, which in turn can spread into our town's wildlife, endangering native plants and species.

**Protect your health and your neighbor's:** Wastewater can contain disease causing bacteria and toxic chemicals. If maintained properly, a septic system will filter and remove most of these dangerous substances. Otherwise, it can leak causing groundwater contamination, spreading disease to you and your neighbors in various ways.

### **What You Need to Know**

As of April, 2021, the Township did away with geographically based cycles for the Septic Management Program. Instead, the program is now administered by mail notice on a basis of permit status. Just keep an eye out for a notification card/letter from the Township in your mail.

When your current On-Lot Disposal Inspection permit expires, this reminder will notify you that your septic system is due for inspection by the end of the year.

Keep in mind that it is best to have your private well water tested around the same time you are having your septic system pumped/inspected, as it is also required by Ordinance #299.

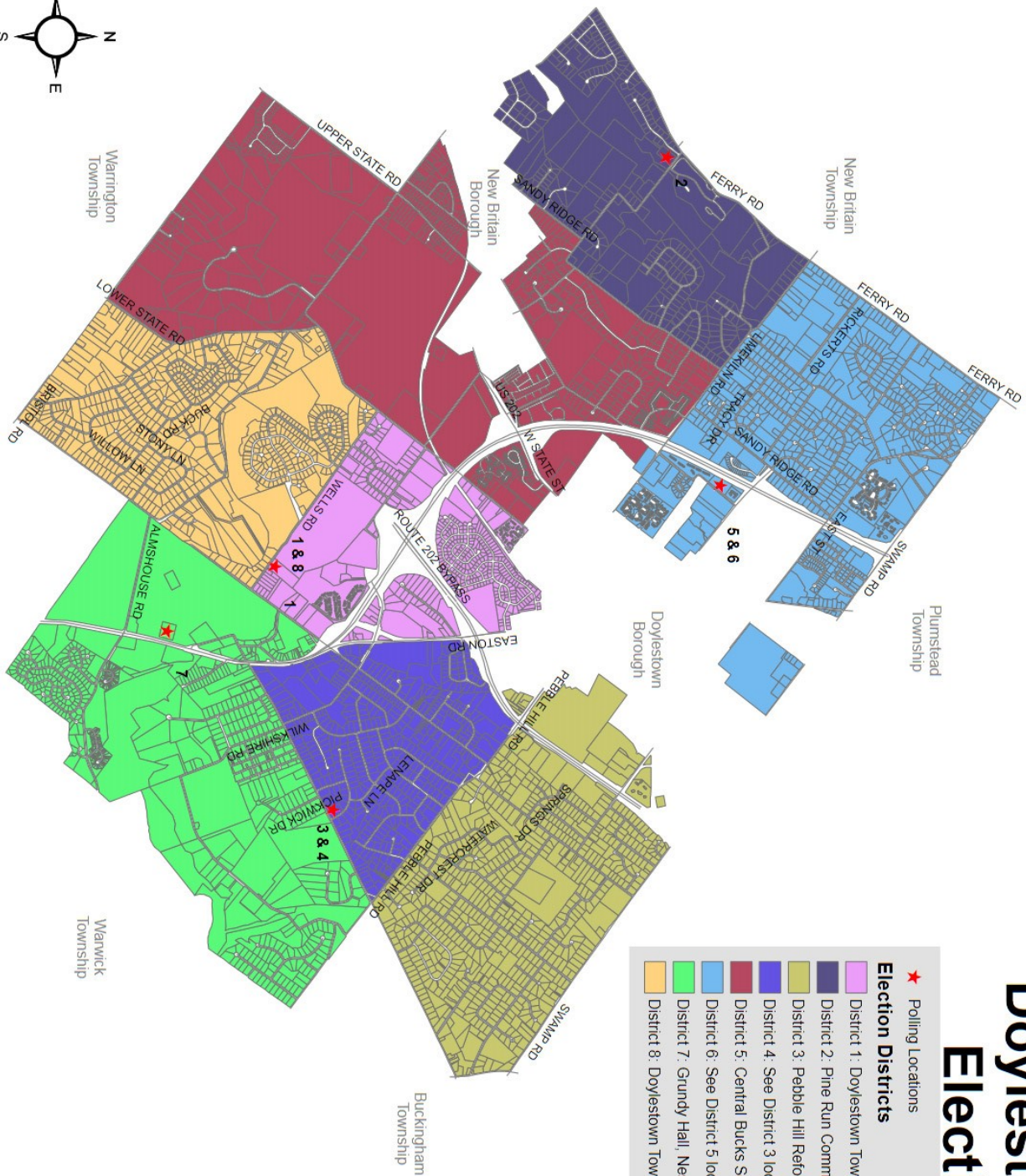
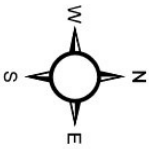
