# **REPORTS**

#### **AUTHORITY ENGINEER'S REPORT**

# DTMA DESIGN, BIDDING AND CONSTRUCTION SUPPORT SERVICES FOR PFAS TREATMENT FACILITY UPDATE

Mr. Ciottoni provided the following updates relative to this project:

- The DTMA currently has a verbal agreement with Gilmore & Associates (G&A) on this contract and is awaiting contract execution.
- A "kick-off" meeting was held the week of June 4th.

Following Mr. Ciottoni's update, a discussion ensued regarding the possibility of proposing a bonus to Gilmore & Associates as an incentive to get the project application into PennVest by their November 1 deadline. The goal of this incentive is to cover potential G&A staffing and overtime costs, if necessary.

Upon a motion by Mr. Van Houten, seconded by Mr. Stairiker, the DTMA unanimously approved a potential addendum to the DTMA PFAS treatment contract with Gilmore & Associates offering a financial incentive not to exceed \$23,000 for submitting all necessary permit applications for Phase I of the DTMA PFAS project to PennVest no later than September 15.

### **AUTHORITY SOLICITOR'S REPORT**

No report was issued by the Authority Solicitor at this time.

#### **EXECUTIVE DIRECTOR'S REPORT**

# REQUEST TO SEND EQUIPMENT TO AUCTION

Mr. Hass referenced the board packet outlining efforts to auction DTMA equipment. The equipment is no longer used by the DTMA.

Mr. Van Houten made a motion authorizing the auction of various DTMA equipment to the Municibid online auction and J.J. Kane Auctioneers as described by Mr. Hass in his memo to the Board dated June 12, 2023. Mr. Green seconded the motion and the motion was unanimously approved by the Authority.

#### DROUGHT IMPACTS

Mr. Hass provided a brief update regarding the current groundwater and surface water deficit due to the lack of sufficient rainfall and the increase in demand for water. He explained that the NWWA is asking customers for a voluntary cut-back of water. In expectation of an imminent Drought Watch issuance by DEP for Bucks and Montgomery Counties, Mr. Hass indicated DTMA will post on their website conservation measures. Mr. Hass and Mr. Ciottoni will also review and update the DTMA drought contingency plan.

# **NEW BUSINESS**

Mr. Green made a motion to approve the June 2023 Bills List for the General Fund Account in the amount of \$86,274.53; Developers Escrow Fund in the amount of \$5,056.26; Capital Improvement Fund in the amount of \$14,677.64; Prepaid Invoices in the amount of \$548.39; Prepaid ACH Credit Invoices in the amount of \$11,646.74; and Transfers to the Township in the amount of \$99,551.69. Mr. Stone seconded the motion and the motion was then unanimously approved by the Authority.
