## Doylestown Township Environmental Advisory Council Meeting Minutes JULY 11, 2023

- Public Comment
  - O John Shiver Bird Town Presented a check for \$500 to TWP EAC
    - This is a part of the \$10,000 that Penn Community Bank donated
    - Hopes that this can go toward native plant install

John also shared the water pump (POPULO Hybrid Water Transfer Pump, about \$140), that was purchased to water the trees in the Ash Way basin that is being restored

- Approval of Meeting Minutes May 8, 2023
  - Approved
- Budget Review
  - About \$2500 remaining (does not include expenses for floating garden)
- New Business:
  - o Heritage Tree Program
    - Marcello M. volunteered to help Anne with the effort
    - Now measured 6 trees Respondents saw it in e-news blast
      - 5 Residents
      - Champion Tree
      - Significant Tree (tree that doesn't meet the standard for Champion)
      - Anne has a mock up of the certificate but can't edit on her computer
        - O Will work with Stacy to edit
      - Anne requested up to \$250 materials for the program to be able to measure
      - Suggested doing a feature on this program and the trees in the fall newsletter
      - Need to determine if/how to list the addresses of the residents of the Champion trees
        - O Does the application ask for their permission?
  - O Naturalized TWP property follow-up from previous meeting guests voicing concern.
    - Stacy and Jeannine visited the property
      - It looked very pleasing to the TWP but the residents thought it looked unkempt and were very upset
      - The TWP agreed to resume mowing
  - Joint Meeting with Parks and Rec in October
    - Parks and Rec suggested a joint meeting in fall 2023
    - Jim is going to meet with their chair to discuss a joint agenda
    - Topics to discuss

- Signage
- Clear the air on funding for golf outing
- Send ideas to Jim offline for agenda items
- o Annual Summit
  - Do we want to conduct one?
  - We have been invited to one in Upper Dublin and EAC Network
  - Team aligned with not hosting one this year but rather get involved in the other 2 EAC Summits
- Bird Town Updates
  - Heidi Shiver was absent from the meeting and will share updates offline
- Recycling Facility tour at WM, Philadelphia
  - Jim reached out to Waste Management and will coordinate dates probably in October
  - Location is in Lower Bucks
  - Max group size is 8
  - Must wear closed toed shoes
  - Only during business hours
- Native Plant Garden/Central Park Pond/Lenape Garden
  - Native Demo Garden certified as Pollinator Friendly Garden every 6 weeks (Penn State Extension)
    - Group agreed to pay the \$30 for the certification
  - Jeannine meeting with representatives from other groups from Bucks Co. Demonstration Garden Association on a quarterly basis
    - Will have access to signage from Penn State Extension Master Gardener Network
    - Jeannine needs a good photo for the garden to incorporate into the signage
      - Jim suggested he has a semi-professional photographer that can help
  - Central Park Pond Erich installed floating garden
    - Suggested installation of a larger floating filtration garden at the infeed of the pond
      - Stacy recommended that Chris and Dave needed to be looped into the conversation
      - O Jeannine suggested that Erich work with his Master Watershed Extension contact for the signage she has access to.
- Knotweed on the Neshaminy Trail
  - Tabling topic bringing up at next month's meeting
- Climate Action Planning/Board Presentation August 15
  - Jim and Kurt providing an update to the BOS in August
  - List of top 25 energy users in the TWP will be contacted.

- Request for faculty volunteers from DelVal got 3 volunteers and a meeting will be arranged
- Watershed Friendly Properties (Sheridan Rd/Ash Way)
  - Project was slowed due to the bid process on the tree removal
  - Team will stop collecting cardboard for the effort
    - Jeannine to communicate to Kara Raymond
- o Single Use plastics action; next steps?
  - Stacy said the solicitor is in the middle of several other initiatives and plastic is a lower priority
  - Likely will not get reviewed until the fall or early next year.
  - Kurt will reach out to the Borough EAC contact to see if there has been any public or business feedback
