- Environmental Programming
 - Heidi - Posing 3-5 different programs throughout the year
 - The struggle is finding someone to run the programs
 - Program guide is going together for Winter '24 right now - still soliciting ideas so may be able to get a program in
 - Spring deadline is due in February '24 for Spring '24 events
 - All programs operate at break-even or better (would need to charge for those events)
 - EAC needs to provide top 5-6 ideas for the year
 - Suggested Jim B connecting with Parks & Rec between monthly meetings
 - Parks & Rec meeting is just prior to EAC meeting
- Deer Control
 - Near TWP have 10-20x increase in deer population
 - Fencing is expensive option but may be better than alternatives
 - Consider areas within parks for exclusionary fencing - Hart's Woods in particular
 - Is sponsorship possible?
 - Need to get engineering/architecture estimates
 - Need to continue with the educational
 - Jim will do some homework on different types of fencing and minimum size and maintenance and present to the BOS
 - Burpee
 - Bowman's Hill
 - Delaware Botanic Garden
 - Citizen Science opportunity

- Public Comment
 - Joe Salvati from Parks and Rec
- Approval of Meeting Minutes – September 2023
 - Tabled until next meeting
- Budget Review
 - Lenape Garden Signage would need to be submitted by late December - bill must come in first 20 days of next year
 - Heidi wants to use \$500 donation for native plant for Hart's Woods
 - Stephanie suggested that we would make a formal request to roll over the remaining funds

- Jim motioned that we roll over any remaining funds and the \$500 donation into 2024
- New Business
 - Environmental Impacts of Residential Chickens
 - REQUEST: Resident wanted to inform the EAC of the current requirements and requested that the EAC research be done on the topic and reconsider the current ordinance.
 - Stephanie clarified that EAC is being asked to evaluate the environmental impact of the chickens
 - The planning committee had too many concerns with roosters
 - Made the argument that chickens eat mosquitos and ticks
 - Currently bag all the chicken poop and throw away
 - TWP liberalized the chicken zoning fin 2018
 - Evaluated 16 local townships and 10 required enclosures and 6 did not
 - Doylestown TWP is one of the 6 that does not
 - What is the appropriate number of chickens for 40K sq ft
 - EAC did not see serious negative environmental impacts of increasing the number of chickens
 - Stephanie suggested preparing a memo and submitting it to the planning committee - Jim to write a memo and circulate to the team that only addresses environmental concerns
- Ongoing Activities and Updates
 - Heritage Tree Update
 - Northampton TWP reached out about this program and asked for details b/c they wanted to create a similar program for TWP-owned properties
 - Native Plant Sale
 - Saturday October 14 - Heavy rain predicted
 - Will make a decision by noon on Friday
 - Gino's asked if EAC/Bird Town would be willing to do a May event at their retail location
 - Recycling Facility tour at WM, Philadelphia
 - October 24
 - Attendees will carpool from Doylestown
